
# The Graduate School: Ph.D. in Spanish and Portuguese

The graduate program in Spanish and Portuguese at Northwestern focuses on the diverse Latin American, Iberian, and U.S. Latino literary and cultural traditions.



The program seeks to instill in its students a strong knowledge of multiple approaches to research and scholarship both within Latin American and Peninsular literatures and across the humanities.

The Ph.D. program encourages students to engage in research extending across departmental and disciplinary borders and to traverse regional and chronological boundaries. The faculty's research and teaching interests span diverse times periods, regions, and forms of Latin American, Iberian, and U.S. Latino cultural production.

#### Current Graduate Research Foci:

<u>Aarón Aguilar—Ramírez</u>: Mexican and Cuban history of revolution and migration

<u>Marlon Aquino</u>: Culture as spectacle in Peru in the early decades of the 20th century

<u>Mariana Barreto</u>: Contemporary visual arts and literature in contemporary Peru and Latin America and their role in shaping current democracy

<u>Verónica Dávila</u>: 20th and 21st century Caribbean literature and its relationship to urban popular music along with other cultural manifestations

<u>José Delpino</u>: 20th and 21st century Latin American literature and culture, biopolitics, and critical theory

<u>Lily Frusciante</u>: Forms of narrative, specifically film, novels and testimony, that address questions of memory, identity, and justice during and after Argentina's Dirty War (1976-1983)

<u>Walther Maradiegue</u>: Identities, politics and performance in the Peruvian Andes, based on modern and contemporary history and ethnography

<u>Jack Martínez Arias</u>: Interrelations of literature, economics and mining in late nineteenth and early 20th century Andean narratives

<u>Minwook Oh</u>: Mexican literature and culture in the late 19th century, with an emphasis on "Modernismo" and gender and sexualities

<u>Ivan Pérez</u>: 20<sup>th</sup> century and contemporary Latin American fictions and their intersections with U.S. popular culture

<u>Pedro Varguillas</u>: Electronic dance music in Venezuela (changa tuki), sonic theory and politics

<u>Cintia Vezzani</u>: Relationships between literature, photography and visual arts from the 19th to the 20th century

## The Fellowships

Students will receive guaranteed Graduate School support for 5 years in the form of two years of fellowships and three years of teaching assistantships during years 1 through 5; students will have an additional fellowship support for four summers. In addition, as a graduate student at Northwestern, you will receive full tuition and will be eligible to enroll in a health insurance plan that is entirely subsidized by The Graduate School.
